## THE MASTER'S REPORT

The good weather has finally made it to BC and I wish all members a long and pleasant summer.

We are now into our summer operation during which the office will be manned on the 2<sup>nd</sup> and 4<sup>th</sup> Tuesdays of the month. i.e. July 8, & 22<sup>nd</sup> and August 12<sup>th</sup> & 26<sup>th</sup>. We will return to our weekly Tuesday manning after that.

On April 12<sup>th</sup> we held the second of our special technical events to discuss the changes introduced by the new Canada Shipping Act. Our Deputy Master, Captain Phill Nelson gave a presentation outlining some of the changed requirements and its effect on ship operations.

At noon we paused for a break and enjoyed a nice lunch prepared by Dorothy Hickman, Bonnie Nelson and Thelma Bremner. I thank them for looking after our "physical" needs so well.

After lunch Captain Nelson introduced Captain John Yeung, Manager Compliance & Enforcement, Transport Canada Marine Safety, who gave an excellent presentation on the new certificate structure and explaining the difference between STCW, Domestic and Limited Certification. He distributed charts laying out the requirements for the many certificates now being issued.

I thank Captain Yeung and Captain Nelson for a most interesting event.

May is usually the month we have the joint dinner with the Transportation Club. Unfortunately we received rather late notice of the actual date and both the Deputy Master and myself had scheduled other activities. However, I understand that a fair number of our members attended and enjoyed a presentation by one of our members, Captain Chris Badger, Chief Operating Officer, Vancouver Fraser Port Authority.

Incidentally Chris has been fairly busy of late having just taken part in The Three Peaks Challenge, raising money for the International Sailors Society of Canada. A team of three, Chris, Peter Swanston, a well known local marine lawyer and Corrine Doolan from Seaspans took the challenge to climb Ben Nevis (Scotland), Helvellyn (England) and Snowdon (Wales). They were among many teams from various countries taking part. For the last two mountains the weather was so bad the teams were restricted to climbing approximately half way to the summit.

On June 17<sup>th</sup> I attended the Annual General Meeting of the Western Marine Community. This group of some 30 marine groups meets regularly with members of the governments to exchange views on matters of concern to them. Many of these are also concerns of The Company e.g. Criminalization of Seafarers, Migratory Birds Convention Act and Pollution Regulations.

Our Deputy Master, Captain Phill Nelson gave a report on the activities of the Pacific Coast Marine Review Panel (PACMAR), a group of some 30 marine firms originally set up to supply input to the government regarding the introduction of marine service charges for Coast Guard users.

**We are now halfway through the year and although most members have renewed their membership and paid their dues there are a fair number who have yet to do so. We will be sending out second notices to these members and I hope for a quick response to ensure that they remain members in good standing.**

## **CAPTAIN RALPH JONES**

The Canadian Merchant Service Guild was saddened to learn of the passing of Capt. Ralph Jones on the 26<sup>th</sup> of April 2008. He had served twelve years as president of the Western Branch of the Canadian Merchant Service Guild. After stepping down as President he continued to be active as a Trustee of the same branch until his passing. Capt. Ralph Jones was a well known and highly respected mariner on Canada's West Coast.

Capt. Jones started his sea going career at the age of fourteen during the second world war in the Merchant Marines. Even after being torpedoed on two different occasions he remained in the Merchant Marines until the end of the war.

After the war, Ralph worked ashore for a few years as a mechanic and bull dozer operator. However, shore work was not for Ralph. He went back to sea as a Deckhand for Island Tug and Barge. He sailed on tugs that had wooden hulls with steam power and later on ones with steel hulls and diesel power. Ralph worked his way up through the ranks from Deckhand to Mate and Master on tow-boats. After a number of years working as Master on tow-boats Capt. Ralph successfully completed the BC Coast Pilotage examinations. On the 1<sup>st</sup> of November 1971 Capt. Ralph was licensed as a British Columbia Coast Pilot. For almost two decades, he safely piloted foreign registered deep sea ships along the British Columbia Coast until his retirement on the 30<sup>th</sup> of April 1991.

Capt. Ralph will be long remembered by his family, friends and fellow mariners.

## REPORT OF THE 158<sup>TH</sup> NATIONAL COUNCIL MEETING – 3<sup>RD</sup> JULY 2008

At the meeting several topics were discussed.

1. Strategic Plan. There has been little progress on this recently. Captain Soppitt is heading this up and will be contacting the various Divisions regarding this. Divisions are asked to appoint a local contact for these discussions. Our Deputy Master has been in contact with Captain Soppitt.
2. Web Site. The start up of this newly designed site is being organized through the Newfoundland Division with Captain Carlesberg as backup. The site is now ready to be taken into use. Several requirements are necessary to ensure privacy concerns. Such information will require to be encrypted locally by the Divisional webmaster before entry on to the site and that information would only be available to the National Webmaster and the Divisional webmaster. Captain Tony Crowther has volunteered to be the Vancouver webmaster and has been in touch with them.
3. Fair Treatment of Seafarers. Our National Master, Captain Peter Turner has sent letters outlining our concerns to the Minister of Transport and the Minister of Fisheries. A letter was received from the latter acknowledging the concerns. Captain Turner's letter to CAMM on this subject was published in their magazine. Captain Turner said this was one of the subjects under discussion at I.F.S.M.A. An American Group, The Centre for Seafarers Rights, is very active in this field and there is an upcoming United Nations Conference on this.
4. Company Representation at Meetings. Captain Patterson of Newfoundland & Labrador Division said that they are getting several requests to sit on panels and represent The Company. There is an urgent need to have in place some system to set out Company positions on various subjects. Captain Ratch Wallace, reporting on his attendance at the AGM of The Council of American Master Mariners(CAMM), outlined how the various chapters

can put forward "Views" to their National group. These are then discussed at the AGM and voted on. They then become "Positions" and are entered into a "Positions Folio" and can be used as required. They can be amended or discontinued through time. He suggested that a similar system could be set up here. He said that he had noticed how similar our two organizations were and that there was considerable desire to continue our relationship. His report was distributed to all Divisions. Captain Angus McDonald suggested we should have some guidelines ready for discussion and acceptance at our forthcoming AGM.

5. AGM Arrangements. Captain Patterson gave details of their arrangements. They hope to have a good attendance at their Seminar on "Maritime Resource Solutions".
