#### From the Master Capt. Chris Connor

I am always a little surprised when I realize that August is half over and our normally short summer is waning rapidly. We are already receiving temperature updates from the editor!

As I write this, I am crossing the Southern Gulf of St Lawrence to visit my ancestral family home in Les Isles de la Madeleine. I can not help but admire the efficiency and competence of the officers and crew in turning the vessel around in Souris. It is a full load. Done in less than an hour. I wonder how long it will be before this service starts to see pressure to replace the Canadian flagged ferry and Canadian officers and crew with cheaper foreign workers. It will start like it always does; with complaints about shortages of qualified etc. The company managers crew. encouraged by their accountants will see only the bottom line. The politicians and bureaucrats will not intervene for many reasons and the traveling public could not care less who is operating the vessel as long as the travel is cheap. It is likely a long way off for this operation but not so far off for others.

The AGM is rapidly approaching. If you are not planning to attend the event (our 50th) in Vancouver then be sure to fill out a proxy so that we can vote on your behalf on the national issues.

Immediately preceding the AGM we are holding a one day symposium on risk mitigation and the indiscriminate use of moratoria by governments and regulators, etc. The subject has become very apropos given the recent announcement by the new NDP government in BC to revisit the recent approval for the Kinder Morgan Trans Mountain pipeline. To paraphrase the newspaper article they want to prevent tankers from ever reaching their coast! I believe the company will gain quite a lot of traction with this subject given the timing of recent events.

It has been a busy summer in Halifax. We saw tall ships, Cunard liners, aircraft carriers and all manner of commercial vessels using the port. Traffic is up on the Seaway and the rebound may be starting in the oil and gas sector. The mergers and acquisitions have started anyway.

Horizon Marine has just purchased a very capable construction ship which will be used in the Nova Scotia offshore if the local paper is to be believed.

Local recruiting agencies have been putting out advertisements for non-supervisory and low skilled labour in preparation for mobilizing a MODU into the NS offshore Sector. We will be watching this closely as it develops. The Company is no longer willing to accept vessels with foreign and nonresident crews working under the CNSOPB when highly qualified and skilled Nova Scotia residents remain unemployed.
