Friday January 17, 2020

The morning started decently however that did not last very long before the forecasted one of a kind winter (SNOW) storm started to become a reality. This Friday everything was closed and shutdown. That meant the

provincial government, businesses and schools (and everything). St. John's and surrounding communities declared an emergency for the first time as far as people can remember.

At the same time gas stations also opened for limited number of hours so people can purchase gas and or diesel.

Tuesday the City allowed the grocery shops to open for a limited number of hours. The roads were still in bad shape as some of the roads had only one cut made by the snowplough. The City continuously advised the public not to venture out of their property to allow snow clearing.



Today it was announced that almost everything such as university, colleges and schools will remain closed the rest of the week to allow snow clearing.

Saturday the 25th the emergency was lifted at 6 am. It will take time for the City to operate normally. Some schools will remain closed even on the 27th.



Saturday February 1, 2020

The Nautical Skills Competition (NSC) that was scheduled for January 25th was postponed to today as St. John's NL had one of a kind very sever snow storm.

It is with great sorrow we announce the passing of “Capt. Jim”. We are only now beginning to realize the immense impact he had on so many right across this country and

beyond. We were fortunate to know him as: a loving husband, an amazing dad, and a cherished brother, uncle and cousin. He also always had a very special spot for great-nephew, Mr. E. For others, he was a loyal colleague, a trusted mentor and a treasured friend. He had a very generous heart and a belief in never taking more than you can give – and give, he did. As he would say, he “loved fiercely” and first and foremost was the love he had for his two beautiful daughters, Adrienne and Samantha. He was immensely proud of the women they have become and the lives they have begun with their partners.

A sense of duty and service ran throughout his life and, in particular, his 38 years with the Canadian Coast Guard where he has maintained many solid lifelong friendships. He also had a deep conviction to giving the disadvantaged a fighting chance which was evident through a variety of causes he supported such as his long-standing commitment to World Vision and his assistance for Champ, a sweet disabled pup from Iqaluit.

Jim forged a new life partnership with his wife, Robbin, with whom he ran SILA North, and together they proudly served interests in Canada’s eastern Arctic. His other much-loved role was leading an expanding husky pack with whom he was known for his secret recipe cookies and bacon Sundays. Jim was also a strong voice encouraging inclusion and diversity in the maritime industry through the Company of Master Mariners of Canada (MMC) of which he was a proud member, Divisional Master of the Vancouver Island Division and National Board member.

His sudden and unexpected departure has left all of us completely devastated. We please ask for understanding as his family navigates this difficult time. We wish to reflect on how best to honour this great man

who has been a huge part of our lives and find the appropriate way to show our respect and undying love. Celebrations of life will take place in the months ahead as we try to find our strength and our way forward without him at our side, cheering us on as he always did. Thursday February 13, 2020

Virtual Marine Technology (VMT) receives provincial funding.

"Innovation and Business Development Fund Supports Marine Simulation Training Technology."

The Honourable Siobhan Coady, Minister of Natural Resources, and the Honourable Bernard Davis, Minister of Tourism, Culture, Industry and Innovation, today announced \$524,000 through the Innovation and Business Development Fund for a

project led by Virtual Marine Technology Incorporated.

The project involves an opportunity for market growth for Virtual Marine, resulting in the company securing 20 new high-skilled positions locally – with the capability of bringing cutting-edge technologies to export markets. Over a three-year period, Virtual Marine will build three life boat simulators, which bring together the realism of being in a lifeboat cabin, with the sensation of movement replicating a lifeboat in emergency scenario sea states. These simulators will be built and shipped using local Newfoundland and Labrador suppliers that are part of Virtual Marine's supply chain.

The company will install these offshore training simulators in three locations globally (Scotland, Qatar and Trinidad). This project will allow for an inflow of capital to Newfoundland and Labrador from Virtual Marine's training sales abroad, and result in increased opportunities for additional research with Newfoundland and Labrador post-secondary institutions. The three simulators will also be satellites to the main hub in St. John's, allowing the new data from the simulators to be used to create customized training – ultimately enhancing available offshore emergency training for the oil and gas and other marine sectors locally and globally."

Saturday February 15, 2020

This is the 38th anniversary of the sinking of the Ocean Ranger, taking 84 lives with

it in 1982. This of course happened on the Grand Banks of Newfoundland.

Wednesday February 19, 2020

Regular meeting of the Nautical Skills Competition (NSC) Committee took place at the Marine Institute (MI).

It was observed that the students were more engaged at this NSC. The students also liked the early introduction to various instruments. It was felt that the cargo work needs to be changed for the next competition. It was very good that the National President of the MMC, Capt. Chris Hall was able to attend as one of the judges. There was an expression that it would be a good idea to have two high school students per team.

It was felt that late January would be the best time for NSC. This year it was postponed to first of February due to the extra ordinary snow storm here in St. John's, NL. Nova Scotia Community College (NSCC) also has a NSC. However there they also include engineering students.

Thursday March 12, 2020

The regular monthly meeting of the Division took place at the Crow's Nest at 7 pm. This evening we had a speaker. Ms Charlene Johnson, CEO of Newfoundland Oil and Gas Industries Association (NOIA).

She gave a very interesting presentation including some most eye opening numbers.

She said offshore resource assessments of NL indicate that we have 52 billion barrels of oil and 199 trillion cubic feet of gas. She said we have well trained people in NL. She indicated we have had 50 / 55 exploration wells and expect 100 wells during the next 10 years.

Ms Johnson indicated that 36% of GDP of Newfoundland and Labrador comes from oil and gas. She also indicated that this sector provides about \$2 billion in labour income; about \$100 billion in royalties and taxes; about \$4.6 billion in labour income; about \$3.5 billion in consumer spending.

The province of Newfoundland and Labrador has declared a Public Health Emergency in Newfoundland and Labrador (18 March 2020).

That means anyone not in compliance could be subject to a \$500 to \$2,500 fine or even prison time. Corporations face more significant penalties—such as \$5,000 to \$50,000 fines—and directors of corporations can be held personally liable. Each day individuals or corporations are not in compliance will result in another layer of penalties.

Gyms and other fitness facilities, bars and arenas must close, and there can be no gatherings of over 50 people. Restaurants which can maintain proper social distancing can remain open.

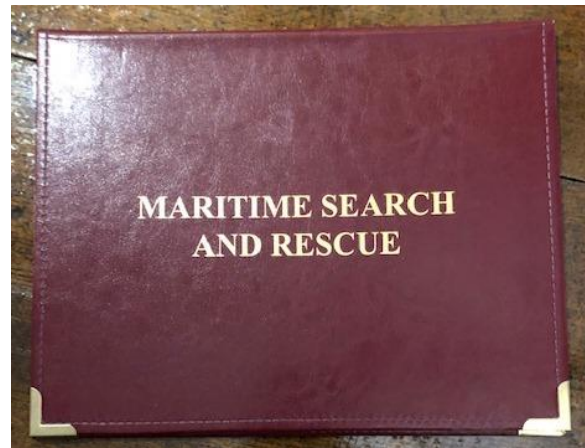
Supply Vessel BURIN SEA

The Captain of the supply vessel Burin Sea was Captain Eben March. When the vessel was sold the company retrieved from the vessel a very important certificate. Five fishermen who escaped from a burning fishing boat northeast of St. John's early Tuesday credited safety training for saving their lives.

The skipper and crew of the Marine Clipper II leapt from the boat into a life-raft after noticing fire. Other fishing vessels in the area responded quickly.

"Nobody understands how fast it actually happened," one of the crewmembers told CBC News after he and his crew arrived in

St. John's aboard the **supply vessel Burin Sea**.

"Within minutes from the time we [saw] the fire and smoke till we were in the life-raft ... we didn't have time to check. It was really quick," said the crewmember, who would not identify himself.

The fisherman and his co-workers said they survived the ordeal because they had been diligent in their training, particularly in how to don survival suits.

All but one of the crew was able to put on survival suits before they escaped from the burning boat.

The following contributed by Captain Eben March – related to m/v Burin Sea:

On May 4, 2010, the Burin Sea was on route to St. John's 14 miles east of the harbour entrance. At 09:12, a mayday call came in on channel 16 VHF. The only

information relayed was the position of the vessel. Sea conditions were 3 - 3.5 meter seas and 28-33 knots of wind. Water temperature was 3 degrees Celsius. Visibility was reduced to less than three miles with some rain.

The Chief Mate on watch immediately copied the position and determined the vessel was 15 miles north of the Burin Sea. This position was then confirmed with Coast Guard Radio and Vessel Traffic Services both out of St. John's. There was no further radio traffic from the mayday vessel. After several unsuccessful contact attempts by Coast Guard Radio, the mayday position was confirmed through recorded tapes of all radio communications.

The Coast Guard requested the Burin Sea to proceed to the position of the mayday to investigate. The Burin Sea altered course towards the mayday position given at 09:12 and the estimated ETA was approximately sixty minutes.

Crew on watch was instructed to prepare for the possibility of rescued individuals coming on board. The Port FRC prepared for launch. The Chief Mate retrieved and entered the mayday position in the GPS to be used by both FRCs.

When the Burin Sea was six miles from the location of the mayday vessel, a second vessel, the fishing vessel Goldorak, reported it was close to the position and could see a life raft in the water. The Goldorak could not confirm if persons were in the life raft. The decision was made to launch the Port FRC with three Burin Sea crew members onboard. The burning fishing vessel was then confirmed to be the Marine Clipper II.

The Burin Sea was approximately four miles from mayday location. The Stbd FRC was ready to launch with another three Burin Sea crew members onboard. The Stbd FRC

was launched and preceded in the direction of the Port FRC. The Port FRC was heading towards the life raft and the Goldorak.

When the Port FRC was approximately three miles from the life raft, the Goldorak reported that all five individuals from the mayday vessel were in the life raft. It was reported that one person was not wearing an immersion suit and appeared to be extremely cold. The decision was made to transport individuals from the life raft to the Burin Sea using two FRCs.

The Port FRC returned to the Stbd side of the Burin Sea with three individuals and was recovered. The individual with no immersion suit was quickly wrapped in additional blankets and was assisted to the ships hospital for assessment. The other two individuals appeared to be in good condition and were assisted in entering the ships accommodations. The Stbd FRC returned to the Port Side of the Burin Sea with the two remaining individuals and was recovered. These individuals appeared to be in good condition and were assisted in entering the ships accommodations.

All recovered individuals were wet and given dry clothing and blankets.

The Burin Sea was instructed by the Coast Guard to return to port. Other vessels would recover the life raft, EPIRB and attend to the Marine Clipper II.

Lindsay and I are also grateful for your friendship with our father and what you have done for him. It means a lot to us.*

Because of the COVID-19 Pandemic, Angus' funeral service will be held later. We will let you know as soon as we have an idea of when.

He was humbled by these awards; as a family, we were delighted in this recognition.*
